## **REPORTS**

**Police Chief:** Police Sergeant Jeff Dawson gave the August monthly report.

- 1) Reported that there were 266 calls for service.
- 2) Reported that there have been 2097 calls for service year to date.
- 3) Reported that there were 44 traffic citations and 37 traffic warnings for the month.
- 4) Reported that there were 4 misdemeanor arrests, 2 felony cases, and 4 warrant arrests.

Mayor: Mayor Brett Essex gave the August monthly report.

- 1) Stated that he attended the Muskingum University Convocation.
- 2) Stated that he and the Village Administrator attended the OMEGA conference held at Muskingum University.
- 3) Stated that he attended student involvement day at Muskingum University and is planning to work with Will Crawford, president of the student senate.

**Fiscal Officer:** Fiscal Officer Lynn Marlatt gave the August monthly report.

- 1) Reported that the fund status is \$754,335.
- 2) Reported that \$37,505 is in reserve for the 2020 debt payment on the new aerial truck and \$18,993 is in reserve for additional engine repairs.

Village Administrator: Village Administrator Charlotte Colley gave the August monthly report.

- Water Production for August–7,329,030 gallons
- Wastewater Flows for August–7,003,480 gallons
- 1) Reported that all plant operations staff passed annual lab certifications required by the Ohio EPA.
- 2) Reported that the Operations staff removed hanging baskets from light poles and are painting curbs and stop bars, as well as preparing for the paving project.
- 3) Reported that the 2019 Street Improvement Project will begin with milling paving the week of September 23.
- 4) Reported that project locations and specifications have been provided to concrete contractors who will be submitting quotes in September for the 2019 Sidewalk Project.

- 5) Reported that the StoryFest event was successful and will be held next year on Sunday, September 6, 2020.
- 6) Special Projects Manager Jim Lenner sent in his report that he worked on projects for the Village for a total of 11 hours in August.

Policy Committee: Baier reported that the committee met on Wednesday, September 4.

- 1) Committee recommends waiving a third reading and passing Ordinance 2019-1, which will allow the Village to codify the ordinances of the Village.
- 2) Committee recommends passage of Ordinance G-9-19-1, which will allow for an assessment of grass mowing costs to property tax for a property that the Village has been mowing.
- 3) Reported that the committee received information on new life insurance coverage for Village employees.

**Finance Committee:** Stevic reported that the committee met at 12 PM.

- 1) Committee recommends Resolution 9-19-1, which will allow the Village to accept the proposal from Peoples Bank for a 7-year loan at an interest rate of 2.79% to finance the 1997 Aerial Platform Truck for the fire department.
- 2) Committee recommends passage of Resolution 9-19-2, which is an annual resolution to access money for the street assessment fund.
- 3) Committee recommends passage of Resolution 9-19-3, which is housekeeping movement of money within various funds.
- 4) Committee recommends passage of Resolution 9-19-4, which will allow the fiscal officer to issue an RFP to obtain financing for a K9 cruiser and to accept the lowest and best financing proposal and to authorize the Mayor to enter into a purchase agreement to purchase the K9 cruiser.
- 5) Committee heard a financial overview from the fiscal officer. Committee learned that the Village has met 81% of its projected revenue for the year, and had 67% of its expenses paid, including larger debt payments for the year.
- 6) Mayor Essex expressed his thank to the finance committee for their recent work.
