

ORDINANCE NO. D-10-86-1

An Ordinance authorizing and directing the Village Administrator of the Village of New Concord, Ohio, to advertise for bids and enter into an agreement for electric energy to operate the municipal Water Works and Sewage Disposal Systems of said Village.

Be it ordained by the Council of the Village of New Concord, Ohio, and it is hereby ordained by authority of the same.

SECTION 1. That the Village Administrator of said Village be and is hereby authorized, directed, and empowered to advertise for bids and enter into an agreement for obtaining the electric energy necessary to operate the municipal Water Works and Sewage Disposal Systems of said Village, in accordance with specifications dated September 8, 1986, which are on file in the office of said Village Administrator and which have been presented and read at this meeting, and which specifications are hereby approved and ordered to be identified by the presiding officer and Clerk of this Council.


SECTION 2. Payment for said electric energy shall be made by said Village in accordance with the terms of said specifications and in the amount specified in the accepted bid.

SECTION 3. That the foregoing advertisement be made by the Village Clerk by posting notices for such bids in five of the most public places in the Village, which five places are hereby determined to be as follows:

- One at New Concord Post Office,
- One at Mutual Federal Bank of Zanesville, New Concord Branch,
- One at New Concord Branch, John McIntire Library,
- One at First National Bank of Zanesville, New Concord Branch, and
- One at New Concord Village Hall.

SECTION 4. This ordinance shall take effect and be in force from and after the earliest period allowed by law.



IN THE COUNCIL OF THE VILLAGE OF NEW CONCORD, OHIO

ORDINANCE NO. D-7-86-2

AN ORDINANCE TO PROHIBIT ADDITIONAL WATER TAPS TO PROPERTIES LOCATED OUTSIDE THE VILLAGE LIMITS.

WHEREAS, the Village of New Concord operates the Village Water System, and

WHEREAS, it is impractical and uneconomical for the Village to permit additional water taps to the areas outside the Village corporation limits, and

WHEREAS, it is in the best interests of the public health safety and welfare of the Village to immediately stop further water taps outside the village corporation limits without permission of the Village Council.

NOW, THEREFORE, be it hereby ordered that:

Section 1. The Village of New Concord shall not permit additional water taps for properties located outside the Village corporation limits without permission of the Village Council.

Section 2. That this Ordinance take effect and be in force from and after its passage and approval by the Mayor.
