Ordinance No. D-8-89-1

AN ORDINANCE AUTHORIZING A CONTRACT FOR THE ACCEPTANCE OF COMPATIBLE WASTE OF A NON-RESIDENT OF THE VILLAGE FOR TREATMENT AND DISPOSAL BY THE VILLAGE OF NEW CONCORD.

WHEREAS, the Village of New Concord desires to enter an agreement with an individual who is not a resident of the Village of New Concord for the acceptance for the compatible waste for treatment in the waste water treatment plant of the Village of New Concord and disposal by the Village of New Concord; and

WHEREAS, the Village of New Concord shall receive direct payment for the treatment of said compatible waste in the waste water treatment plant of the Village of New Concord; and

WHEREAS, the waste water treatment plant of the Village of New Concord has the capacity and ability to treat waste in addition to the treatment of the waste of the residents of the Village; and

WHEREAS, the acceptance and treatment of the compatible waste of an individual who is not a resident of the Village of New Concord is just and equitable to the Village and the residents of the Village for the reason that said treatment will generate revenue for the operation and maintenance of the waste water treatment plant.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of New Concord, Ohio, that:

Section 1. The Mayor and Clerk be and hereby are authorized and directed to enter into a contract with Saint Charles Power Packaging of St. Charles, Illinois, dba Power Packaging, Inc., (hereinafter referred to as "Power Packaging, Inc.") an Illinois corporation whose local address is 100 Hope Road, Byesville, Ohio, for the acceptance of compatible waste, at the discretion of the Village, for treatment and disposal of the Village of New Concord at its waste water treatment plant.

Section 2. Said contract shall provide for the payment by Power Packaging, Inc. for the disposal of its waste by the Village of New Concord, which payment shall exceed the cost to the Village of accepting, treating, and disposing of said waste.

Section 3. This ordinance shall take effect and be in full force from and after the earliest period allowed by law.
