

IN THE COUNCIL OF THE VILLAGE OF NEW CONCORD, OHIO

ORDINANCE NO. D-8-92-1

AN ORDINANCE TO AMEND ORDINANCE NO. D-2-91-1 RELATIVE TO THE TAPPING CHARGES FOR WATER TAPS AND RESPONSIBILITIES BETWEEN THE VILLAGE AND OWNER FOR THE WATER TAP AND WATER LINE.

WHEREAS, it is in the best interest of the Village that the rates for tapping charges set by Ordinance No. D-2-91-1 in 1991 be increased to cover the cost of inflation and other factors; and

WHEREAS, it is the intention of Council to define the relative rates and obligations to the parties concerning the access to and maintenance of the water line and water tap.

NOW, THEREFORE, be it ordained by the Council of the Village of New Concord, Ohio, that:

SECTION 1. Section 1. of Ordinance no. D-10-86-2 is hereby amended to read as follows:

Tapping Charges. The following charges shall be made for connection to the Village water supply system.

3/4 inch	\$375 plus costs of excavation and an appropriate meter which shall be supplied by the Village.
1 inch	\$400 plus costs of excavation and an appropriate meter which shall be supplied by the Village.
2 inch	\$1,400 plus costs of excavation and an appropriate meter which shall be supplied by the Village.
4 inch	\$2,250 plus costs of excavation and an appropriate meter which shall be supplied by the Village.

The fee for lineal feet of excavation between the location of the water main and the curb boxes shall be:

\$10.00 - per lineal foot of street, alley, sidewalk, curb or other improved ground.

\$ 5.00 - per lineal foot of unimproved ground.

Excavation through rock, under utilities or more than four feet deep shall be considered extra ordinary.

There shall be an extra charge for extraordinary installation requirements. Said charge shall be established by the Village Administrator. The Village residents should contact the Village Administrator before construction and installation to determine if special conditions warrant additional charges and to receive a statement of all costs associated with the installation of a resident with a statements of cost in writing. All fees shall be paid in advance.

SECTION 2. Water taps may be installed by outside contractors in new subdivisions or developments, providing that the design and installation is inspected and approved by the Village Council and Administrator. In such cases there shall be a fee for meters and the appropriate tapping fees to finance the cost of improvements to the water system in order to supply the additional potable water.

SECTION 3. The Village shall be responsible for providing owner access to the water system at the curb stop on owner's property line. The Village shall be responsible for materials and labor required for the maintenance, repair and replacement of the water line from the tap on the main or feeder line to the curb stop. The owner shall be responsible for maintenance, repair and replacement of the water line from the curb stop to the property serviced with water.

SECTION 4. The provisions of this ordinance shall become effective at the earliest date allowed by law.
