

IN THE COUNCIL OF THE VILLAGE OF NEW CONCORD, OHIO

**ORDINANCE NO. D-1-03-2**

AN ORDINANCE TO AMEND ORDINANCE NO. D-8-94-1 AND D-8-92-1 ESTABLISHING CHARGES AND RATES FOR WATER SERVICES AND FOR WATER USE AND FOR TAPS TO THE VILLAGE WATER SYSTEM.

WHEREAS, the Council of the Village of New Concord must establish water service rates in order to operate the water system; and

WHEREAS, it is necessary that revised rates for water service be established; such rates to become effective beginning the March 1, 2003 billing period. These revised charges are necessary for the cost and expense of operating the water system for the Village of New Concord in compliance with rules and regulations of the Environmental Protection Agency.

NOW, THEREFORE, be it hereby ordained by the Council of the Village of New Concord as follows:

Section 1. That all properties within the Village Corporation limits to which a connection is made to the Village Water System shall be charged for water based on water consumption per bi-monthly period, which charges shall be computed as follows:

First	4,000 gallons	\$5.00 per 1,000 gallons
Next	8,000 gallons	\$4.60 per 1,000 gallons
Over	12,000 gallons	\$4.00 per 1,000 gallons

The minimum water charge per bi-monthly period is \$20.00.

Section 2. That all properties outside the Village Corporation limits to which a connection is made to the Village Water System shall be charged for water based on water consumption per bi-monthly period, which charges shall be computed as follows:

First	4,000 gallons	\$10.00 per 1,000 gallons
Next	8,000 gallons	\$ 9.20 per 1,000 gallons
Over	12,000 gallons	\$ 8.00 per 1,000 gallons

The minimum water charge per bi-monthly period is \$40.00.

Section 3. Tapping Charges. The following charges shall be made for connection to the Village water supply system.

¾ inch - \$750 plus cost of excavation and an appropriate meter which shall be supplied by the Village.

1 inch - \$800 plus costs of excavation and an appropriate meter which shall be supplied by the Village.

2 inch - \$2,800 plus costs of excavation and an appropriate meter which shall be supplied by the Village.

4 inch - \$4,500 plus costs of excavation and an appropriate meter which shall be supplied by the Village.

6 inch - \$6,000 plus costs of excavation and an appropriate meter which shall be supplied by the Village.

The fee for lineal feet of excavation between the location of the water main and the curb boxes shall be:

\$20.00 – per lineal foot of street, alley, sidewalk, curb or other improved ground.

\$10.00 – per lineal foot of unimproved ground.

Excavation through rock, under utilities or more than four feet deep shall be considered extra ordinary.

There shall be an extra charge for extraordinary installation requirements. Said charge shall be established by the Village Administrator.


Water taps may be installed by outside contractors in new subdivisions or developments, providing that the design and installation is inspected and approved by the Village Council or Administrator. In such cases, the tapping fee shall be reduced by an amount determined by the Village Administrator or Council.

The Village shall be responsible for providing owner access to the water system at the curb stop near owner's property line after all fees are paid. The Village shall be responsible for materials and labor required for the maintenance, repair and replacement of the water line from the tap on the main or feeder line to the curb stop. The owner shall be responsible for maintenance, repair and replacement of the water line from the curb stop to the property serviced with water.


Section 4. Restrictions and fees for taps outside the corporation limits are listed in previous ordinances. See: D-2-97-1, D-1-98-1, D-5-93-1, D-3-91-1 and D-2-91-2.

Section 5. That the rates and charges set forth herein shall be in full force on the effective dates listed above.


