**ORDINANCE NO. D-8-96-1**

AN ORDINANCE AMENDING ORDINANCE NO. D-8-94-2, ESTABLISHING A BASE SEWER RENTAL CHARGE FOR THE USE OF THE VILLAGE SEWAGE SYSTEM, AND DECLARING AN EMERGENCY.

**WHEREAS**, the rates for sewer services are set forth in Ordinance No. D-8-94-2, and

**WHEREAS**, the Council of the Village of New Concord must establish new sewer rates, and

**WHEREAS**, it is necessary that revised rates for sewer use be established; such rates to become effective August 13, 1996. These revised charges are necessary for the cost and expense of operating the sewer system for the Village of New Concord, and

**WHEREAS**, the immediate adoption of this ordinance is necessary for the health, safety and welfare of the Village.

**NOW, THEREFORE**, be it hereby ordained by the Council of the Village of New Concord, as follows:

Section 1. For the use of and the service rendered by said sewage works, rates and charges shall be collected from the owners of each and every lot, parcel of real estate or building that is connected with the Village sanitary system or otherwise discharges sanitary sewage, industrial wastes, water or other liquids, either directly or indirectly, into the sanitary sewerage system of the Village of New Concord. Such rates and charges include user charges, debt service costs, excessive strength surcharges and other service charges, which rates and charges shall be payable as hereinafter provided and shall be in an amount, determinable as follows:

- (a) The sewage rates and charges shall be based on the quantity of water used (based on water meter readings) on or in the property or premises subject to such rates. Sewage service bills shall be rendered once every two (2) months (or period equaling two (2) months). The schedule on which said rates and charges shall be determined as follows:

Bi-Monthly Usage

All users \$2.75 per 1,000 gallons (4,000 gallon minimum)


Minimum Bi-Monthly Charge - \$11.00

- (b) For the service rendered to the Village of New Concord, the same shall be subject to the same rates and charges hereinabove provided, or to charges and rates established in harmony therewith.

- (c) In the event that a sewer user operates a private well, he shall have an outside remote reading meter installed on the well at this own expense.

Section 2. That this ordinance shall be declared an emergency, take effect immediately and the rates and charges set forth herein shall be in full force and effect on August 13.




