A RESOLUTION TRANSFERRING VARIOUS SUMS OF MONEY IN THE YEAR 2019 BUDGET FROM VARIOUS FUNDS LISTED HEREIN TO VARIOUS ACCOUNT CODES LISTED AND TO DECLARE AN EMERGENCY.




