

IN THE COUNCIL OF THE VILLAGE OF NEW CONCORD, OHIO

RESOLUTION NO. 2020-7-18

A RESOLUTION DETERMINING TO PROCEED WITH THE SUBMISSION TO THE ELECTORS OF THE QUESTION OF A REPLACEMENT LEVY FOR A TAX IN EXCESS OF THE 10 MILL LIMITATION IN ACCORDANCE WITH SECTION 5705.34 OF THE OHIO REVISED CODE TO PROVIDE FOR THE GENERAL CONSTRUCTION, RECONSTRUCTION, RESURFACING, REPAIR AND MAINTENANCE OF STREETS, ROADS AND BRIDGES IN THE VILLAGE OF NEW CONCORD, OHIO AND DECLARING AN EMERGENCY.

WHEREAS, on July 13, 2015, this Council adopted a resolution determining to submit to the electors of the Village of New Concord, Muskingum County, Ohio, the question of levying a tax in excess of the ten-mill limitation, as described below, a copy of which resolution was certified to the County Auditor of Muskingum County; and

WHEREAS, the County Auditor has certified to the Council that the total current tax valuation of the Village of New Concord is \$40,411,170 and the dollar amount of revenue that would be produced annually by the millage stated below would be \$129,316.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of New Concord, Muskingum County, Ohio, that;

Section 1. This Council desires and determines to proceed with the submission to the electors of the question levying a tax in excess of the ten-mill limitation for the benefit of the Village of New Concord, Muskingum County, Ohio, for the purpose of the general construction, reconstruction, resurfacing, maintenance and repair of streets, roads and bridges in the Village at a rate not exceeding 3.2 mills for each one dollar of valuation, which amounts to thirty-two cents (\$.32) for each one hundred dollars of valuation, for five (5) years, and which this levy is a replacement of an existing levy of three and two tenths (3.2) mills.


Section 2. The question of approving the levy shall be submitted to the electors of the Village of New Concord at the election to be held on November 3, 2020, and that said levy be placed on the tax lists of the current tax year, commencing in 2020 first due in calendar year 2021, in compliance with the provisions of ORC Section 5705.34, if a majority of the electors voting thereon vote in favor thereof.

Section 3. The Fiscal Office is hereby directed to certify a copy of the Resolution to the Board of Elections, Muskingum County, Ohio, not less than seventy-five days before the election, and notify said Board of Elections to cause notice of election on the question of levying said tax to be given as required by law.

Section 4. It is found and determined that all formal actions of the Council concerning and relating to the adoption of this resolution were adopted in an open meeting of this Council and that all deliberations of Council of any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with the law.


Section 5. That this measure constitutes an emergency measure for the immediate preservation of public peace, health and safety and shall take effect and be in force at the earliest period allowed by law.
