# **April 12, 2021**

Mayor Jennifer Lyle called the meeting to order on Monday, April 12, 2021 with all members present.

Moved by Sabino, second by Wootton that council dispense with the reading of the March 8, 2021, March 17, 2021, and the April 6, 2021 minutes and approve as distributed. Motion carried.

Mayor Lyle introduced Dr. Sandra Schroer and Michaela Snider. Schroer and Snider explained the work that they have been doing to update maps for the New Concord Cemetery. Lyle and council thank them for their many hours of work.

### REPORTS

**Police Chief:** Police Chief Mindy Peck gave the March monthly report.

- 1) Reported that there were 198 calls for service.
- 2) Reported that there have been 604 calls for service year to date.
- 3) Reported that there were 24 traffic citations and 35 traffic warnings for the month.
- 4) Reported that there were 81 traffic citations and 81 traffic warnings year to date.
- 5) Reported that there were 2 misdemeanor arrests and 5 warrant arrests.
- 6) Thanked the Robert E. Fellers Foundation for the donation of \$5000 to the K9 fund.

**Fire Chief:** Fire Chief Matthew Hamsher gave the March monthly report.

- 1) Reported that there were 65 total EMS runs for the month.
- 2) Reported that there were 17 fire runs.
- 3) Reported that there have been 214 runs combined year to date.
- 4) Reported that the fire department is working on recruitment.
- 5) Reported that the department has done several CPR classes.

Mayor: Mayor Lyle gave her March report.

- 1) Reported on several upcoming events- Let's Pick It Up New Concord will be held April 22 to 30; Celebrate New Concord will be occurring this summer; the New Concord Area Pool will be opening May 28; and there will be a John Glenn Centennial Celebration in July.
- 2) Reported that the American Rescue Plan will provide the Village with funds for the next two years.

Fiscal Officer: Fiscal Officer Lynn Marlatt gave the March monthly report.

- 1) Reported the fund status is \$959,964.
- 2) Reported that she received the first have of the real estate settlement from the county for tax year 2020. The general fund received \$72,486; the street assessment fund

- received \$79,413; and the Garland Hotel TIF received \$106,100 to be forwarded to Garland Real Estate for the Public Improvement payment per the TIF agreement.
- 3) Reported that appropriated expenditures are 20% of the amount budgeted as of March 31, 2021.
- 4) Reported that the projected revenue is 28% of the budgeted amount as of March 31, 2021.
- 5) Reported the following water/wastewater totals:
  - Water Production for March 6,868,350 gallons
  - Wastewater Production for March 12,782,100 gallons
- 6) Reported that the operations department has been preparing the pool for opening, as well as preparing for mowing.
- 7) Reported that Dalton Flinn has been hired to work in the water and wastewater plant, and that Josh Deem has been hired to work in the operations department.

**Infrastructure Committee:** Committee Chair Robert Dickson reported that the infrastructure committee met in a joint meeting with the finance committee on Monday, April 12.

1) Committee recommends passage of Ordinance 2021-31, which is an update to the right of way ordinance.

**Finance Committee:** Committee Chair Steve Wootton stated that the finance committee met in a joint meeting with the infrastructure committee on Monday, April 12.

- 1) Committee recommends passage of Ordinance 2021—32, which is an amendment to the salary of the NCAARD Program Director.
- 2) Committee recommends passage of Ordinance 2021-33, Resolution 2021-4-47 and Resolution 2021-4-48, which are routine housekeeping finance items.
- 3) Committee recommends passage of Resolution 2021-4-46, which allows for the Village to enter into the ODOT road salt contract.
- 4) Committee heard about repairs needed for the New Concord Area Swimming Pool. These funds can be taken from previously budgeted expenses that ended up not being needed. Kearns thanked Operations Manager Matt Wood for his work at the pool.
