RESOLUTION 2022 – 11 – 106

A RESOLUTION TRANSFERRING VARIOUS SUMS OF MONEY IN THE YEAR 2022 BUDGET FROM VARIOUS FUNDS LISTED HEREIN TO VARIOUS ACCOUNT CODES LISTED AND TO DECLARE AN EMERGENCY.

WHEREAS, monies from the various funds of the Village of New Concord may be transferred to various account object code according to law; and

WHEREAS, it is immediately necessary that the Fiscal Officer be able to pay operating expenses and other expenses of the Village for the preservation for the public peace, health, welfare and safety of the Village of New Concord.

NOW, THEREFORE, be it resolved by the Council of the Village of New Concord, Ohio that:
