ORDINANCE NO. 2023 – 93

AN ORDINANCE AMENDING ORDINANCE 2023-78 TO ESTABLISH WAGES FOR EMPLOYEES AND OFFICERS OF THE VILLAGE FOR THE PERIOD 4-1-2023 TO 3-31-2024 AND DECLARING AN EMERGENCY.

WHEREAS, it is necessary to establish salaries and wages by ordinance in order to comply with the statutes of the State of Ohio; and

WHEREAS, Village Council desires to adjust the salaries of said Village employees; and

WHEREAS, it is in the interest of the health, safety and welfare of the Village that this Ordinance take effect immediately.
