## IN THE COUNCIL OF THE VILLAGE OF NEW CONCORD, OHIO

## **RESOLUTION 2024 – 7 – 1**

A RESOLUTION DETERMINING TO PROCEED WITH THE SUBMISSION TO THE ELECTORS OF THE QUESTION OF LEVYING A TAX IN EXCESS OF THE TEN-MILL LIMITATION RC 5705.03(A), RC 5705.25, RC 5705.26

WHEREAS, on May 22, 2024, this Council adopted Resolution 2024-5-1 determining to submit to the electors of the Village of New Concord, Ohio, the question of levying a tax in excess of the tenmill limitation, as described below, a copy of which resolution was certified to the County Auditor of Muskingum County; and

WHEREAS, the County Auditor has certified to this Council that an estimated annual levy of 3.2 mills for each \$1.00 of taxable value, which is \$112.00 for each \$100,000 of the county auditor's appraised value, which will be required to produce the annual amount required set forth in the Resolution of Necessity (Resolution 2024-5-1); and

WHEREAS, the County Auditor has certified to this Council that the total current tax valuation of the Village of New Concord, Muskingum County, Ohio is \$41,889,510.00 and the dollar amount of revenue that will be produced annually by the millage stated below would be \$134,000.

NOW, THEREFORE, BE IT RESOLVED by the Council for the Village of New Concord, Ohio, that:

<u>Section 1.</u> This Council desires and determines to proceed with the submission to the electors of the question of levying a tax in excess of the ten-mill limitation for the benefit of the Village of New Concord, Ohio for the purpose of general construction, reconstruction, resurfacing, maintenance and repair of streets, roads and bridges in the Village

<u>Section 2.</u> Said levy is a replacement of a 3.2 mill levy, which amounts to \$0.0032 for each dollar of valuation, for five years.

<u>Section 3.</u> The question of approving the levy shall be submitted to the electors of the Village of New Concord, Ohio at the election to be held on November 5, 2024, and that said levy be placed on the tax lists commencing in 2025, first due in calendar year 2026, in compliance with the provisions of Section 5705.34, if a majority of the electors voting thereon vote in favor thereof.

<u>Section 4.</u> The Fiscal Officer of the Village of New Concord, Ohio is hereby directed to certify a copy of this Resolution to Proceed to the Board of Elections, Muskingum County, Ohio, not less than ninety days before the election, and notify said Board of Elections to cause notice of election on the question of levying said tax to be given as required by law.

Section 5. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all

deliberations of this Council and of any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with the law.
