## IN THE COUNCIL OF THE VILLAGE OF NEW CONCORD, OHIO

## **RESOLUTION 2024 - 7 - 4**

A RESOLUTION DECLARING IT NECESSARY TO LEVY A TAX IN EXCESS OF THE 10 MILL LIMITATION TO PROVIDE FOR THE GENERAL CONSTRUCTION, RECONSTRUCTION, RESURFACING, REPAIR AND MAINTENANCE OF STREETS, ROADS AND BRIDGES IN THE VILLAGE OF NEW CONCORD, OHIO AND DECLARING AN EMERGENCY.

RC 5705.19(G), RC 5705.191, RC 5705.25, RC 5705.26

WHEREAS, the Village of New Concord has many streets, roads and bridges in need of general construction, reconstruction, resurfacing, repair and maintenance; and

WHEREAS, on November 3, 2020, the residents of the Village of New Concord approved a replacement 3.2 mill levy for the purpose of general construction, reconstruction, resurfacing, repair and maintenance of the streets, roads and bridges in the Village for a five-year period beginning with a tax list and duplicate for the year 2020 as provided in the O.R.C. 5705.19 (G); and

WHEREAS, said replacement 3.2 mill levy shall expire in 2024; and

WHEREAS, it is necessary to levy a tax in excess of the 10 mill levy limitation, as provided in the O.R.C. 5705.07, for the benefit of the Village of New Concord for the purpose previously stated herein; and

WHEREAS, the immediate adoption of this Resolution is in the best interest of the health, safety, and welfare of the residents of the Village of New Concord to levy a tax for such purposes that streets, roads and bridges may become in disrepair if the Village does not place this proposed tax levy on the ballot for the general election to be held on November 5, 2024.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of New Concord, State of Ohio, that:

<u>SECTION 1</u>: It is hereby found, determined and declared that the amount of taxes which may be raised by the Village of New Concord within the 10 mill limitation by levies on the current tax list and duplicate will be insufficient to provide an adequate amount for the general construction, reconstruction, resurfacing and repair of the streets, roads and bridges in the Village, and that it is necessary to levy a tax in excess of that limitation for the purpose of general construction, reconstruction, resurfacing, and repair of the streets, roads and bridges in the Village in the amount of 3.2 mills, which amounts to 32 cents for each one hundred dollars of valuation each year, for a five-year period, and which levy is the replacement of an existing levy of 3.2 mills.

<u>SECTION 2</u>: The question of approving the levy shall be submitted to the electors for the Village of New Concord at the election to be held on November 5, 2024, and that said levy be placed on the tax lists of the current tax year, commencing in 2025, first due in calendar year 2026, in compliance with the provisions of Section 5705.34, if a majority of the electors voting thereon vote in favor thereof.

<u>SECTION 3</u>: That the Fiscal Officer of the Village of New Concord is hereby directed to certify a copy of this resolution to the County Auditor of Muskingum County, Ohio requesting that the County Auditor certify to the village the total current tax value of the Village of New Concord and the dollar amount of revenue that would be generated by the 3.2 mill levy.

<u>SECTION 4</u>: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this resolution were adopted in an open meeting, and all deliberations of this Council and

of its committees that resulted in their formal action were in meetings open to the public, in compliance with all the law.

<u>SECTION</u> 5: This Resolution of Necessity to levy a tax in excess of the ten-mill limitation is an emergency and shall take effect at the earliest time as permitted by law.
