ORDINANCE NO. 2024 – 10 -- 1

AN ORDINANCE PROVIDING FOR AMENDING AND REVISING SPECIFIC LINE-ITEMS IN THE APPROPRIATIONS OF EXPENDITURES FOR THE VILLAGE OF NEW CONCORD FOR THE CALENDAR YEAR 2024 AND DECLARING AN EMERGENCY

WHEREAS, it is necessary to revise and/or establish appropriations for Village Expenditures, and
