ORDINANCE NO. 2025 – 10 – 1

AN ORDINANCE PROVIDING FOR AMENDING AND REVISING SPECIFIC LINE-ITEMS IN THE APPROPRIATIONS OF EXPENDITURES FOR THE VILLAGE OF NEW CONCORD FOR THE CALENDAR YEAR 2025 AND DECLARING AN EMERGENCY

WHEREAS, it is necessary to revise and/or establish appropriations for Village Expenditures, and

WHEREAS, this Ordinance constitutes an emergency measure providing for the daily operations of all Municipal Departments.




SECTION 5. This ordinance is passed as an emergency and shall be effective October 14, 2025.


